which CompTel had mailed to a prospect in Denver. Bowling says that he tried in vain to obtain a copy of CompTel's brochure from the home office in Raleigh. The brochure advertised a 6-month toll-free telephone service (up to 100 calls per month-each not to exceed 5 minutes duration) for \$216-payable in advance.

The local Bureau attempted unsuccessfully to reach the President of CompTel on August 7. Several more calls were made with the same results. The Attorney General's Office was contacted and the Bureau was informed that CompTel was being scrutinized by

their office. In September the State Attorney General's Office issued a Temporary Restraining Order and filed a lawsuit against Hal Kitt Snyder (President) and CompTel, Inc. Snyder was also arrested and charged for mail fraud. Reportedly, CompTel bilked customers to the tune of \$120,000 and owes \$35,000 for advertising.

The ongoing experience with CompTel, Inc. serves to remind us that the triangle Area is not immune to con artists or questionable business operations," contends Bowling.
