**General Motors Spends \$224 Million With Vendors**

DETROIT — General Motors spent \$224 million with minority-owned and operated suppliers in the United States during 1980, Chairman Roger B. Smith reported today.

"This is a record for General Motors and exceeds the previous record of \$199.4 million in 1979 by 13 percent," Mr. Smith said. "General Motors cumulative purchases from minority suppliers since the inception of this program in 1968 amount to \$786.7 million."

He also noted that the number of suppliers in the program has increased to 994 in 1980.

"Once again, General Motors has made a significant step forward in development of minority enterprise, particularly in light of the current economic conditions," Smith said. "This is proof of GM's dedication to its minority supplier program."

"It is our goal at General Motors, in all areas of activity, to encourage minority-owned and operated small businesses, and it is our intention to continue to make progress along these lines."

GM's minority supplier development program under the direction of Robert B. Stone, vice president in charge of the Materials Management Staff. Personnel from numerous corporate and divisional activities are involved in the implementation and success of this program.

**Chuck Stone To Speak At UNC March 22**

CHAPEL HILL — Chuck Stone, senior editor and columnist for the Philadelphia Daily News, will visit the University of North Carolina at Chapel Hill on March 22 to speak on minorities working the media.

The free public lecture will be held at 8 p.m. in Hamilton Hall auditorium.

Stone has been a congressional aide, a White

House correspondent and a television commentator. He is the founder of the National Association for Black Journalists and one of the first blacks to become a columnist for a daily newspaper in the United States.

Stone's visit will coincide with a special minorities conference at the UNC-CH Scholl of Journalism. The conference, which will be held for about 25 North Carolina newspaper editors, is designed to encourage the hiring of more minority journalists. It is sponsored by the American Society of Newspaper Editors and the Gannett Newspaper Foundation, Inc.
