Howard University graduated 25% of a blacks who received doctorates in the physical sciences in 1979.

In 1977, predominant white institution graduated only 5.3% of all blacks receiving master's degrees and 3.1% of blacks receiving first professional degrees in the country.

In North Carolina there are eleven predominantly black institutions which, along with five historically black institutions in Virginia—Hampton Institute, Norfolk State College, St. Paul's College, Virginia State University and Virginia Union University—make up a sixteen institution Health Science Consortium. The consortium exists to train black for careers in the health professions.

In 1978-1979, 405 consortium graduates enrolled in professional and occupational health schools and there was almost no attrition rate for those enrolled in medical schools; one out of 201; in dental schools, there were only two out of sixty and in professional and occupational health school other than dental and medical schools, there were none out of 14; students enrolled.

The North Carolina Health Manpower Program, Chapel Hill, functions as the state's program to coordinate the admission of consortium graduates to the health professional school across the country.
