Virginia Union Universit - make up a sixteen institution Health Scienc Consortium. The consor tium exists to train black for careers in the healt! professions.

In 1978-1979, 405 con sortium graduates enroll ed in professional and oc cupational health schools and there was almost no attrition rate for thos enrolled in medica schools: one out of 201; it dental schools, there were only two out of sixty and in professional and oc cupational health school other than dental and medical schools, therwere none out of 14: students enrolled.

The North Carolin Health Manpower Pro gram, Chapel Hill, func tions as the state's pro gram to coordinate the ad mission of consortiun graduates to the healt professional school across the country.
