The Durham City Council will hold a performance evaluation public hearing to review program progress and performance during the recently completed 1981-82 Community Development program year. Interested citizens are invited to attend the public

hearing and comment on the City's performance durong the program year.

During the 1981-82 Community Development program year, the City conducted housing rehabilitation

Albright/Calvin Street neighborhood strategy areas (NSA's).

A new housing rehabilitation financing program was developed and implemented which is designed to stimulate more interest in the housing programs of the city, improve performance, and leverage the more limited funds now available for such programs.

The City completed its clearance activities in the three clearance areas in the St. Theresa NSA: Enterprise Street, Beamon-Johns Streets, and the Matthew-Fargo Streets area. The City began a Moderate Rehabilitation housing program and has commitments for 174 units in the St. Theresa and North Albright/Calvin Street NSA's and in other areas of the city. The City funded housing rehabilitation in the Old North Durham neighborhood through the Neighborhood Housing Services, Inc.
The Department of Planning and Community

Development completed a conceptual plan for the redevelopment of the NCR-54 urban renewal area. a concept plan for the Edgement neighborhood, a citywide neighborhood analysis in preparation for the 3-year 1982-85 Community Development Block Grant program and a one year plan for the 1982-83 CDBG

program.
The St. Theresa NSA redevelopment plan was revised to encourage redevelopment in the three clearance areas and to reflect other changing conditions in the NSA. A Crest Street Plan was developed clearance areas and to reflect other changing conditions in the NSA. A Crest Street Plan was developed and approved including housing rehabilitation, the moving of houses out of the proposed East-West Expressway alignment and new housing construction. Interim assistance activities including minor repairs, painting, weatherization, demelition of dilapidated housing requested by the neighborhood, were conducted in both the Crest Street and Edgemont neighborhoods during 1981-82 as an interim measure until final plans can be agreed upon.

An Economic Development Data and Analysis Report was completed and a citywide Economic Development Task Force was appointed. Six subcommittees of the Task Force are producing reports profiling six Economic Development subject area goals, problems and recommendations. A vacant multi-family housing site inventory of seventy locations was completed and distributed to developers who may be interested in developing those parcels with new housing.

Finally, during the 1981-82 CDBG program year, the City expended \$2,437,459.59. Through June 30, 1982, the City has spent 82.7% of its \$17,095,459.59 entitlement from the Federal Department of Housing and Urban Development.
