As Affecting the Farmer

- 1 Raise more horses and mules. Exports for both military and industrial use are expected to be largely increased. 2 Raise more livestock of all kinds. Exports of beef cattle and of purebred cows for the dairy will increase. 3 Raise more poultry. Exports of cattle will shorten the home beef supply, increasing the price of meat, and stimulating the demand for eggs and poultry. 4 Export of Corn, Wheat, Rice and Hay will be largely increased. 5 The price of all staple agricultural products will be largely increased, except cotton. No change in the price of tobacco.

MORAL

Raise More livestock in 1915 and 9 16. Sow grain and hay for 1915; especially corn, wheat and rice. Do not increase the tobacco acreage, and do reduce the cotton acreage. Begin this spring a regular system of crop rotation with a good diversification of products, thus forever preventing a repetition of 1914.
