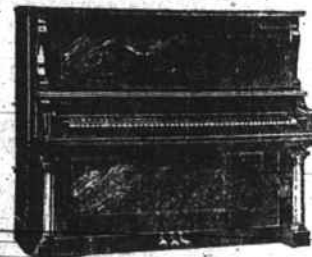

An election was granted by the County Commissioners yesterday to lengthen the public school term here, but owing to the remoteness of portions of the district, and that we have recently voted a \$15,000 bond issue to build a railroad from Rocky Mount to this place, and the agitation of a tax to improve our public roads will cause a strong opposition to the measure.

He had long been a true and consistent member of the Baptist church and was an honest, honorable and true citizen. His funeral was preached by Rev. G. M. Duke and his remains were tenderly laid to rest at his home in the presence of a number of friends. We are glad to note that Dr. T. C. Ceppegge and his most excellent wife have decided not to move to Centerville, but will remain with us.

SMALL POX ORDER

The Board of County Commissioners at their regular meeting on Monday, February 7th, 1910 passed the following order:

Ordered that the County Superintendent of Public Health be and he is hereby authorized and empowered to vaccinate all persons in Franklin County, who, in his opinion by reason of exposure or location may be in danger of contraction or spreading small pox and quarantine all such persons in his opinion the public health may require.

Be it ordered further that any person refusing to submit to vaccination or quarantine regulations shall be guilty of a misdemeanor and shall on conviction be fined not exceeding \$50 and not exceeding thirty days in prison.

And be it further, ordered that each day refusal to submit to vaccination or quarantine regulations shall constitute a separate offense within the meaning of the regulations for the public health.

Be it ordered that all prisoners confined in jail or sentenced to work on the public roads of Franklin county shall be vaccinated by the Superintendent of Public Health at the County's expense.
