

in the matter of the 1922 crop. The cooperative association received 10.565 bales of long staple cotton of the crop of 1922. Prior to this final settlement the members had been advanced on this type of cotton on a ba sis of 19 cents a pound basis middling staple 7-8 to 1 inch. On this basis the advance ranged from 25 to 28 cents a pound. The association found that pound. The association found that during the season there were many times when it was impossible to sell the long staple cotton for a satisfac-tory price and rather than let it go under what was believed to be a prop-or wice sales were not made. Finaler price sales were not made. Final-ly all of the cotton was sold and the final settlement with the members

foilowed. Members of the association received a final settlement on the 1922 short staple cotton last October but at that time all of the long staple had not been sold. 
