F. Jones lot (now Farmers Co-operative Company's lot) and the C. B. Cheatham lot, formerly the Boatwright Prize House lot (now Allen Machine Company's lot) on Main street an iron stake; thence along the C. B. Cheatham line (now Allen Machine Company's line) S 58 E 234 feet more or less to the corner of the Tar River Manufacturing Company's lot, formerly the Cooper lot (now John S. Howell's lot) in the line of the S. A. L. Railway Company; thence along the line of the S. A. L. Railway N 26 3-4 W 279 feet more or less, to the corner of said railway on Main street; thence along Main street S 33 1-4 W 144 feet more or less to the point of beginning.
