GENERAL FOREIGN NEWS.

LONDON, Dec. 27.—A meeting of the Irish Home Manufacture Association in Dublin adopted a resolution to communicate with Messrs. Gray and Dawson and other members of the late Industrial Exhibition Committee, with a view of having an exhibition of Irish manufactures in 1882.

The Hamburg American line steamer Gellert, Captain Kulewein, from New York, December 15, for Hamburg, ran ashore to day during a fog off Cuxhaven. Six tugs have been sent to her assistance, and a steamer has been despatched to take off her passengers if necessary.

A despatch from Constantinople says: 'The Messageries Maritimes steamer Provence has been sunk by a collision. The loss of the steamer and cargo is estimated at £240,000.'

LONDON, Dec. 29.—The Standard's Vienna despatch says: 'Reports from Warsaw show that the damage done property during the recent riot there is enormous. A portion of the city was virtually destroyed.'

St. Petersburg, Dec. 28.—The Geographical Society has resolved to do all that is possible to assist the crew of the Jeannette.

ODESSA, Dec. 28.—It is calculated that the Odessa magazines contain 1,500,000 quarters of grain ready for exportation, and the other Black Sea ports an equal quantity. The total is valued at 30,000,000 rubles. The business is quiet because of low prices in England and France.

LONDON, Dec. 28, 1881.—A despatch from Tangiers says that French troops have entered Fignig. Fighting has ensued between them and tribes within the frontier. Ten thousand Tunisian refugees have arrived forty miles west of Tripoli. The authorities of Tripoli have interned Ali Ben Amar, chief of the Oned-Ayar tribe. The correspondent of the Times at Tunis says: 'The practical results of General Foregemol's march are apparently indecisive, as a column is to be formed at Tabessa, Algeria, which will re-enter the Tunisian region in February by the way of Nepta.' A despatch to the News from Marseilles reports that M. Koustan has embarked for Tunis.

Defence of Property.

LONDON, Dec. 28, 1881.—The Lord Mayor continues to energetically advocate the fund for the defence of property in Ireland which has now reached the sum of £9,000. The Lord Mayor publishes a letter from Mr. Gladstone, dated on Saturday last, exonerating him from party motives in his promotion of the fund. The circular of the Ladies' League, summoning all branches of that organization to meet on Sunday, is issued for the purpose of testing the legality of the ladies' meeting. A machinist in the office of the United Ireland has been arrested and conveyed to Dundalk Jail. Mr. Forster, Chief Secretary for Ireland, has requested five of the recently appointed magistrates to inform Earl Cowper, Lord Lieutenant of Ireland whether the police in their respective districts are sufficient. Mr. Forster also requests the magistrates to report in regard to the working of the protection acts. At an influential meeting of land-owners and traders of the city and county of Dublin, a branch of the Property Defence Association was formed. Ryan and the two Whelan brothers, who were arrested at the time of the seizure of a quantity of arms and ammunition in this city recently, were committed for trial. Mr. Forster has contributed £100 in aid of Vere Forster's Irish emigration scheme for assisting farm servants and others to emigrate to America.

Shot his Betrothed and Himself. BIDEFORD, Me., Dec. 28, 1881.—Leon Moore, of this place, employed as a clerk in a store in Boston, came here a few days ago to spend Christmas. This afternoon at about three o'clock he called upon his affianced, Miss Belle Cushman, an estimable young lady and a teacher in a public school. Shortly after his arrival the other occupants of the house were startled by the reports of a pistol from the room in which the young couple were. They entered and found Miss Cushman dead and Moore just alive. He expired a few minutes after the occupants of the house had reached the room. It is supposed that actuated by jealousy he killed Miss Cushman and then shot himself. They were each twenty-one years of age. The families of both are highly respectable, and they are nearly distracted by the tragedy.

Two Brothers Shot.

MOBILE, Ala., Dec. 28.—Particulars reached here this morning of a most horrible tragedy that occurred in Baldwin county, near Sibley's Mill, opposite Mobile. Joel Johnson, a well known citizen of the neighborhood, was riding quietly along the public road, when he was shot from behind a tree by a negro. The first shot struck Mr. Johnson in the head, stunning him and causing him to fall from his horse. While he lay on the ground the assassin shot him twice again, in the wrist and side, and then dragged him 300 yards and put him in a pond, thinking him dead. The negro then mounted his victim's horse and rode off to a party in the neighborhood. During the night Mr. Johnson, revived by the night air, recovered his senses and dragged himself home, a distance of

half a mile. He told his brother, Abe Johnson, of the assault. His story, together with the fact that the negro had been seen on the horse, led Abe Johnson as deputy sheriff, to arrest him. He found the negro at a place called Jim Malou's. The fellow drew a pistol, whereupon Mr. Johnson shot him. The negro fired back, shooting Mr. Johnson through the breast, and then ran. Mr. Johnson ran a little way after and fired at him, but the negro ran on. A crowd soon collected and started in search of the negro. They found him, about four o'clock in the afternoon, dead, shot through the breast and wrist. He had run about half a mile down the creek and fell on the edge of the swamp.
