Her latest venture in husbands is Marcus Henry Milner, who was born in 1864, while his bride has been visible on earth ever since the good old year of 1818. The Duchess is a well-known figure at all race meetings, and enters and runs her horses with great shrewdness under the track name of Mr. Manton. She was a daily attendant at the recent libel suit of Woods, the jockey, and is a strong and wonderfully well-preserved woman for her age. In addition to her racing speculations she is probably the most ambitious woman matrimonially that ever lived. Her last husband died in 1893, having for seven years been the partner of her joys and betting book. After three years of widow's weeds she was reputed two years ago to have designs on Fred Archer, the jockey, though this is not supposed to have hastened his untimely decease. She is five years older than her new husband's father, but this will not interfere with the felicity of the honeymoon, as the Duchess is proverbially generous, and the marriage settlements are reported to be very large. The marriage will be a great source of relief to Baroness Burdett-Coutts, as it throws her union entirely into the shade, and will relieve her of her long-held position as a matrimonial example."

The prize of \$60,000 offered some years ago by the French Government to any one who should invent a remedy for that destructive disease of the vine, phylloxera, has not yet been awarded, although experiments with some of the remedies proposed have yielded encouraging results. The losses caused by this disease are enormous. About one-half of the vineyards of France have been totally destroyed by it. Mr. Roosevelt, our consul at Bordeaux, reports that the loss caused directly by the destruction of vines is thus far \$2,440,000,000, to which should be added more than \$760,000,000 expended for wine and dried grapes imported to make good the shortage, raising the total loss to \$3,200,000,000. The value of wine imported into France, to be "doctored" in various ways for use at home and sale abroad as the product of French vineyards, has risen from \$1,670,348 in 1875 to \$109,000,000 in 1887.

The Rev. Edmond Hese Swem, a Baptist minister of Washington, D. C., has stirred up the Capital by preaching against the wickedness that prevails in society. Last Sunday night he preached a sermon on "Male and Female Gamblers." These women, he said, "do here on the sly what Parisians do publicly." "Poker playing," he continued, "is a common thing among Washington ladies of fashion and I am told that they play for heavy stakes, and are as bold as the women who sit around the boards at Monte Carlo. They will bet their last dollar on a game of cards. Many of them lose as much as a hundred dollars at a sitting. Four young ladies and two old matrons sat down to a game of poker one night last winter. One of the girls lost two hundred and fifty dollars. The money was won by one of the matrons. The next day the girl called on the matron and asked that her father had given her the money which she lost in order to buy dresses, and asked for its return. "Did that woman return the money?" asked the preacher, in thundering tones. "No, she coldly told her victim, just like a professional gambler, if she could not afford to lose, she had no business to play.
