The Yorktown has exceeded the horse power guaranteed and will earn a premium for her contractors. The Vesuvius has greatly exceeded the speed stipulated, and has become famous throughout the world. These two vessels are the only ones yet tested of those designed under the late secretary's administration, and their success is full of promise for all the

others, most of which are to have speed ranging between that of the Yorktown and that of the Vesuvius. These two are from the same builders, however, and accordingly much interest will be felt to learn the results in the case of the Petrel, built at Baltimore, and the Charleston, built at San Francisco. If these turn out all right, there need be little doubt as to any of the unarmor ed cruisers now under construction.

A new corporation at Buffalo is hard at work converting Niagara Falls into a giant motor. Its presi dent, ex Judge Hamilton, in speaking of it, said: "We are harnessing Niagara as a business enterprise. The great cataract hourly produces or consumes 60,000,000 horse power, and we want some of it. We are making chambers underneath the fall and behind the water, where we have huge standpipes connected with turbine wheels. These supply motive power to a regiment of dynamos, which will send an unlimited amount of the electric current, in any direction. In five years we will offer to 'run every horse car, elevator and engine within one hundred miles of the Falls. We will begin with Buffalo, which we will supply with 40,000 norse power daily before next fall. That accomplished, we will extend the wires to other cities, abroad, and provide them with as much has horse power as they want. We are going to deliver electricity just as the milkman does the morning milk.




