Blaine is wise in saying that he won't oppose Harrison in 1892, and he will thus not only escape the accusation of ingratitude to his chief, but he will have the little power, if any, that the administration can give him when it is finally discovered by Harrison that he isn't in it. Taking the present outlook for the Republicans, it's Blaine or bust for 1892, and it's quite likely to be Blaine and bust as well.

It probably is not true, but it is certainly a good story which the Fargo Argus tells at the expense of Alonzo J. Whitehead, of Duluth, Minn. Says the Argus: "He was the Democratic nominee for Congress in Comstock's district and knew that the only possible chance for success would be through a third ticket being placed in the field. The Alliance nomination had been offered to several and declined. Finally he thought of Kittel Haaverson, who served with him in the Legislature, and he went to him and offered to pay his campaign expenses if he would accept the nomination. He accepted and was elected, and Whitehead now mourns."

The Berliner Volksblatt, since October 12th the organ of the German Social Democracy, announces that the next International Workingmen's Congress will be held in Brussels on August 16-24, 1891. All labor organizations of the world will be invited to send representatives. The reports and other documents must be presented printed in English, French and German. Reports are limited in length to sixteen octavo pages. The executive committee has decided on this order of business: First, discussion of international and national legislation for protecting the workingman; second, consideration of the right of organization and combination, of strikes and boycotts, from the international point of view; third, definition of duties of workmen toward militarism.

Some of the best paying railroads are in new countries. Before their completion it was thought likely they would engulf the capital invested without ever making adequate returns. On the Island of Ceylon, for instance, the receipts of the 180 miles of railroad have been constantly increasing since 1883, and last year the dividends were 11 per cent. on the subscribed capital. The railroad which runs from Rangoon far north to upper Burma has for a number of years paid dividends of 6 and 7 per cent. One of the costliest railroads in the world is that from Rio Janeiro to San Paulo, and yet this road for some years has been one of the most profitable lines in existence. Perhaps one reason why these lines are very profitable is that they have no competition, and are permitted to charge tolerably high tariffs.

It appears from the election returns of Michigan that while the average plurality for the Democrats upon the State ticket was between 3,000 and 4,000, the net plurality of the Democratic candidates for Congress in eight districts was over 10,000. Commenting upon this fact, the Detroit Free Press, Democratic, says: "This shows that in most instances the Democratic candidates for Congress received more than the regular party vote at the recent election. It shows that there were several thousand voters in the State who were so moved by the inequities McKinley tariff law and by the outrageous proceedings of the majority in the House at the last session that, while supporting the Republican State ticket in the mass they cast their ballots in the Congressional districts against the advocates of Reedism and McKinleyism."
