OUR LAW MAKERS. SENATE. THURSDAY, Feb. 13th.

The Senate was called to order at 10 o'clock, President Robinson in the chair.

The Journal of yesterday was read and approved.

PETITIONS AND MEMORIALS. were presented by Senators Nicholson, Caldwell, and Reid.

REPORTS OF STANDING COMMITTEES. were submitted by Senators Nicholson, Eaves, Linton, Epps, Henderson, Everett, Wald, Dotson, Bryon, Shackelford, Wald, Epps, Bryon, of Duplin, and Bryan, of Pender.

BILLS AND RESOLUTIONS. were introduced by Senators Davidson, Shafer, Mebane, Ross, King, Meigs, Henderson, Ward, Nicholson and Wald.

SPECIAL ORDER. The hour having arrived for the special order, which was a bill to abolish the Geological Survey of North Carolina, it was taken up.

The committee to whom this bill was referred suggested that it be amended so as to authorize the appropriation of \$2,000,000 for the purpose of the Geological Survey.

This bill was one of great importance and interest, as was evidenced by the crowded lobby and the utmost interest and attention paid the Senators during the debate.

Mr. Dorch was opposed to the bill. He favored retrenchment and reform, but thought the Senate was acting too hastily in this matter.

Mr. Evert strongly opposed the bill. Mr. Merritt spoke in opposition to the bill and in favor of the survey.

Mr. Clark favored the minority report, as taking from successive Legislatures the right to change what should be unalterably fixed in the constitution.
