CANDIDATES EXPENSES—The new election law, passed by the last Legislature, requires that "every candidate, who is voted for at any public election, held within this State, shall, within ten days after such election, file, as herein after provided, an itemized statement, showing in detail all the moneys contributed or expended by him directly or indirectly, by him self or through any other person in aid of his election." And the law further provides that "any candidate who shall neglect or refuse to file such statement shall forfeit his office." Therefore all candidates, who were elected last week, must file their statement of campaign expenses by tomorrow (Friday) or they will forfeit their offices. These statements must be filed in the office of the clerk of the superior court by all the officers elected in the county. This law applies to magistrates and constables just as much as it does to the other officers, and therefore they had better hurry here to Pittsboro and file their statements with the clerk of the court.

This requirement is one of the "reforms" of the last Legislature which will put a great many candidates to a good deal of unnecessary trouble and inconvenience, and without doing any good. If a candidate is so corrupt as to buy or bribe voters he would not hesitate to do it, and make a false statement of his expenses.
