### **Meekins Denies Claims**

Three lawyers who were responsible for throwing the old Tri-State tobacco association into bankruptcy and who have already been paid \$5,000 each for their services, wanted \$25,000 more apiece of the tobacco growers' money and made claim for that amount. After considering the claim for several months Judge Meekins in federal court has denied it. The judge hopes to find some legal way to turn over the balance of the tobacco money to the new association being formed under provisions of the farm relief act. The three lawyers were W. M. Person of Louisburg, P. W. Glidewell of Reidsville and E. P. Buford of Lawrence-ville, Va.
