### BEER TAX BRINGS IN \$9,139,687 IN APRIL

Washington, May 18.—Legalized beer added \$9,139,687 to the government's revenue in April when nearly every other important form of taxation showed decreases from the previous month.

Collections from the \$5 a barrel tax on beer brought the government \$8,269,052 while the license fees of retail and wholesale dealers in the 3-2 beverage added \$869,811 and the tax on 3.2 wine beverage amounted to \$824.
