## James F. Byrnes Home Purchased By Mrs. Turner

The James F. Byrnes home on boulevard has been sold to Ruth T. Turner, wife of Hamish Turner, general manager of the Carolina Scenic Coach Lines, it was learned Thursday from a deed filed in the office of LeRoy Sellars, register of mesne conveyance.

In the deed, Mrs. Maude B. Byrnes, wife of the former senator and associate justice who Saturday was appointed director of economic stabilization for the nation, conveyed the property to Mrs. Turner for \$5,000 and "other valuable considerations."

The lot on which the home is located fronts 178 feet on Otis boulevard and runs to a depth of 160 feet on Mills avenue.—Spartanburg Herald.

## Recapped Passenger Tires

The following memorandum has been received by the local Rationing Board from the State Rationing Office:

"Since the newspaper story under a Washington headline that appeared on October 1st with reference to increased quotas of recapped passenger tires, this office as well as the local boards, has been literally swamped with inquiries and applications. Unfortunately many people have gained the impression that everyone is now able to obtain recapped tires.

"The increased allotment was intended to assist the Boards to take care of some of the surplus eligible applications now on file. There has been no change whatsoever in the eligibility of any individual to qualify for recaps."
