### TAX TIP (Getting Records Together)...

Question: I have all my W-2's together and have listed my itemized deductions. I received \$100 in interest from a savings and loan association but I have not received a Form 1099 from them. Must I wait until I get this 1099 before I can file my return?

Answer: No. It is not necessary to file Form 1099 with your tax return. The 1099 is merely an information statement that tells you and IRS the amount of interest paid on your account during the year. It is a good idea to verify the amount with the savings firm in order to insure that it agrees with the amount reported to IRS. — Provided as a Public Service of H&R Block, the Income Tax People
