



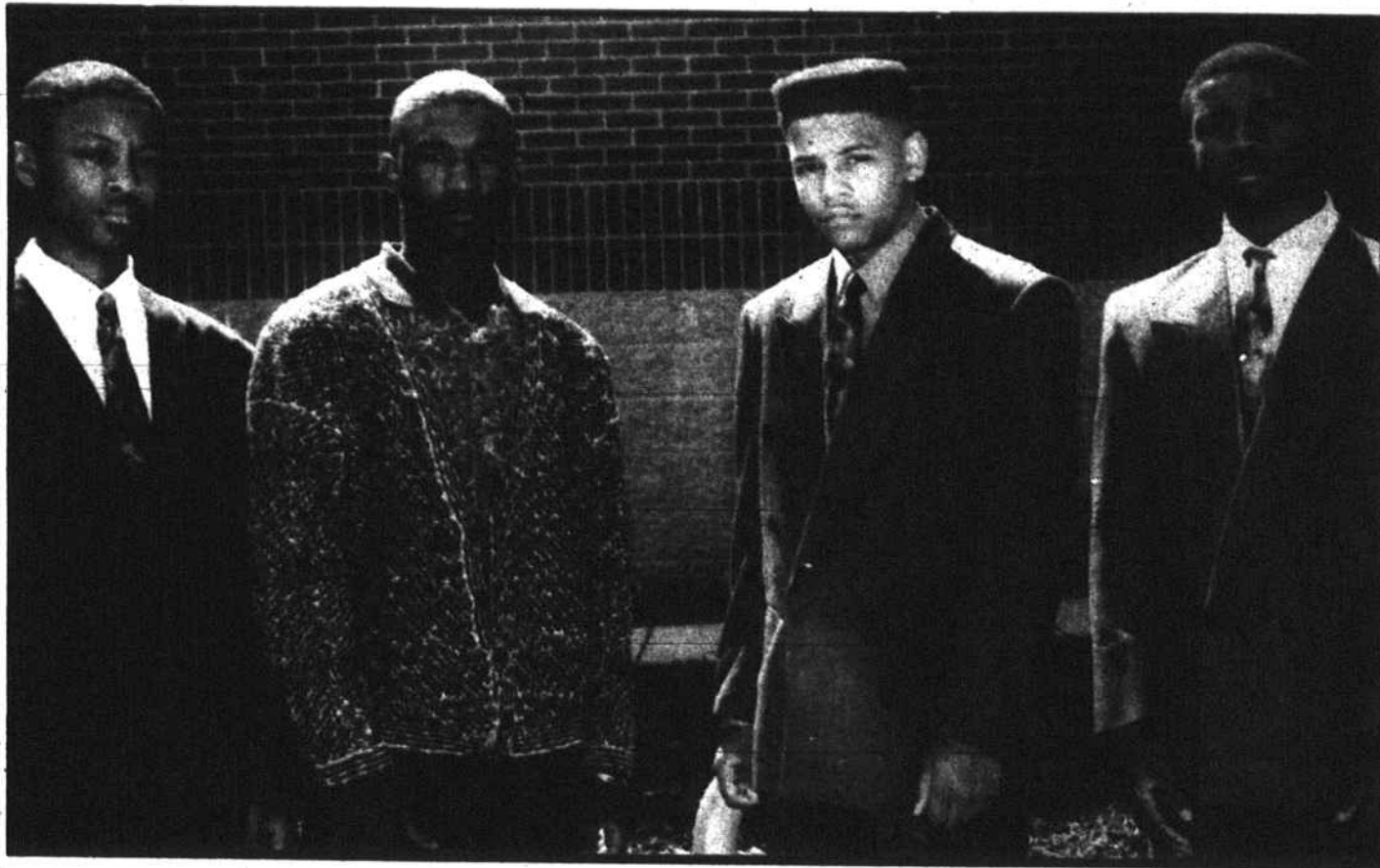

City Seeks Volunteers For Tourism Committee

City residents are invited to apply for volunteer positions on the Forsyth County Tourism Development Authority.

There are three vacant positions. The qualifications for each position is as follows: 1) owner or manager of a hotel with over 100 units, 2) owner or manager of a hotel with 100 or fewer units and 3) someone involved in a visitor- or tourist-related business which is not subject to the occupancy tax.

The authority helps the development of travel, tourism and conventions in Forsyth County through state, national and international advertising and promotion. Appointments are for three years.

Meetings are the fourth Tuesday of every month at 7 p.m. The authority has 13 voting members.

Applicants or anyone making a nomination should write a letter including qualifications, interest, home address and daytime telephone number. Send it to the Mayor's Office, P.O. Box 2511, Winston-Salem, N.C. 27102.

The mayor will make recommendations to the Board of Aldermen; the board makes the appointments. Application deadline is June 30.

sidering adoption or waiting for children.

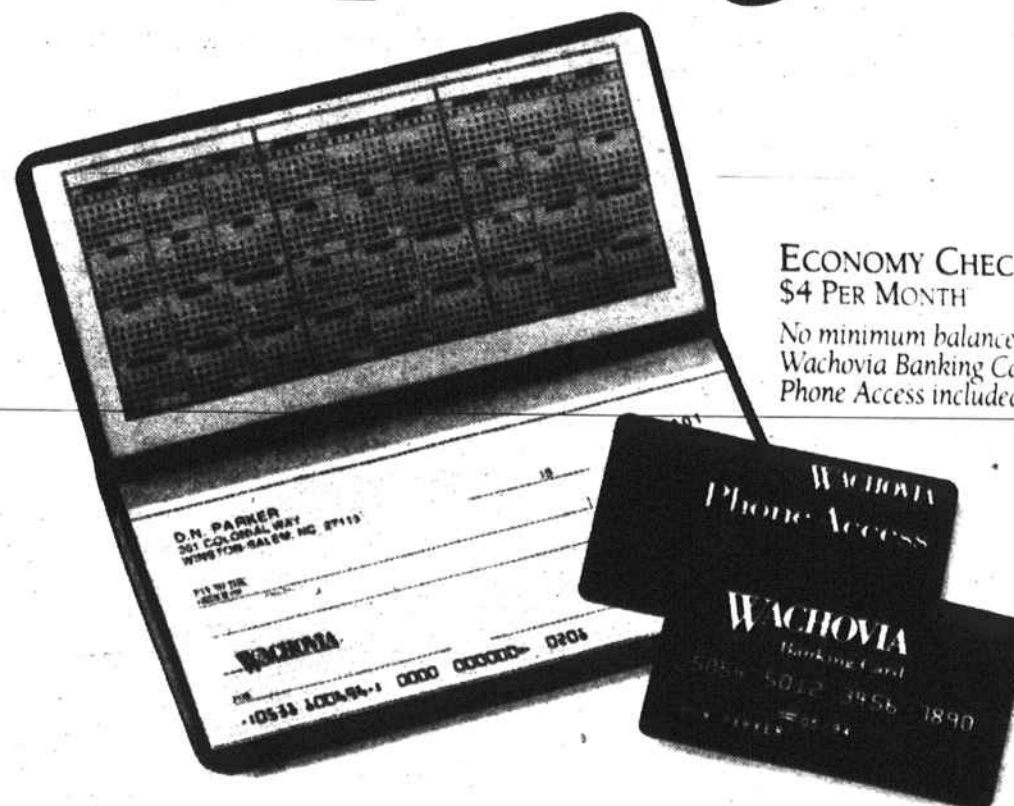
