The North Carolina Department of Transportation will hold the above Public Hearing on Thursday, September 2, 1993 at 7:30 pm. in the Walkertown Middle School Auditorium, 3175 Ruxton Drive, Walkertown.

The hearing will consist of an explanation of the proposed location and design, right of way requirements and procedures, and relocation advisory assistance. The hearing will be open to those present for statements, questions, comments and/or submittal of material pertaining to the proposed project. Additional material may be submitted for a period of 10 days from the date of the hearing to: L.L. Hendricks, P.O. Box 25201, Raleigh, NC 27611.

It is proposed to realign NC 66 to replace the Norfolk and Southern Railroad Underpass. Additional right of way will be required for this project.
