The last day on which qualified voters who have moved their residence from one precinct to another precinct within Forsyth County may transfer their registration in person is also Friday, October 9, 2009. Change of address using a Forsyth County voter card must be received by October 9, 2009 if delivered in person and postmarked by October 9, 2009 if mailed, in order to be valid for the November 3, 2009 Municipal General Election. Otherwise, a person may transfer their precinct on Election Day according to the provision of G.S. 163-82.15 (e). Mail-in registrations must be postmarked by October 9, 2009 to be a valid registration for the November 3, 2009. Municipal General Election. If the applicant or another individual delivers a mail-in form to the Board of Elections, it must be received by 5:00 PM on October 9, 2009. Registration forms by mail are available from the Board of Elections office, public libraries, various government offices, registration drives, and other public locations. Contact the Forsyth County Board of Elections office for a complete

Qualified voters who are not certain whether they are registered should contact the Forsyth County Board of Elections. The registration records will be available for public inspection by any elector of Forsyth County during regular office hours and days of the Forsyth County Board of Elections, 201 N. Chestnut St., Winston-Salem, North Carolina. (Monday - Friday, 8-5).

Mail out no excuse absentee ballots will be allowed in this election for all voters. One-Stop, no excuse absentee voting will take place at the Forsyth County Board of Elections office, October 15, 2009 thru October 31, 2009. Hours are 8:00 AM until 5:00 PM on October 15th, 16th, 17th, 19th, 20th, 21st, 22nd, 23rd, 24th, 26th, 27th, 28th, 29th and 30th, 1:00 PM until 5:00 PM October 18th & 25th and 8:00 AM until 1:00 PM October 31st. You may contact the Forsyth County Board of Elections office for information on additional sites and times.

On Tuesday, November 3, 2009, the date designated for the General Municipal Election, the polls in Forsyth County, North Carolina shall open at the hour of 6:30 AM and shall close at the hour of 7:30 PM.
