The 2011-2012 Annual Plan reflects the fourth year implementation of the 2009-2013 Five-Year Consolidated Plan (CP). The CP is the process of planning and applying for federal funds that are provided to communities on an "entitlement" basis: Community Development Block Grant (CDBG), HOME Investment Partnership (HOME) and Emergency Shelter Grants (ESG) funds. The CP is a combined plan of the City and County as the Winston-Salem/Forsyth Housing Consortium and is a prerequisite to Consortium funding under the HOME program.

2011-2012 Annual Plan implementation includes proposed expenditures from Federal Fiscal Year 2011 appropriations of approximately CDBG (\$1,836,340), HOME (\$1,265,140) and ESG (\$81,849), Housing Finance fund balance, Continuum of Care, carryover G.O. bond funds, and projected program income revenues with a projected total from all fund sources of up to approximately \$7.6 million. A portion of the projected total includes available resources, derived from unexpended prior year funds, which have been allocated to projects and activities to be implemented during the 2011-2012 program year.

Program activities to be undertaken are single-family and multi-family housing rehabilitation, including removal of architectural barriers and control of lead-based paint; emergency repair assistance for owner-occupants, new construction of single-family and multifamily units; mortgage financing for first-time home buyers, with or without rehabilitation; small business loans; contractor and construction training; and public services and facilities that specifically address housing and economic self-sufficiency. Funds are also budgeted for program administration and Section 108 loan repayment.

 Copies of the draft CP will be available for review and comment by April 7, 2011 and the final plan submitted to HUD by May 13, 2011 following public review and comment and submission to the City Council for comment and approval of submission at the April 18, 2011 City Council meeting.

Due to an early payoff of a multi-family rehabilitation loan, projected CDBG program income will increase by \$1,201,278.44 and projected HOME program income by \$84,136.56.
