
Government Center Bonds Issue Offers Many Benefits

By Jalyne Strong Post Staff Writer Tuesday, May 8, along with primary elections, Charlotteans can vote on the City-County Government Center bonds. All registered city residents will be asked to vote for or against the City Council's proposal to build a new and larger, facility for City-County government of-

City officials are stating Charlotte's current that city hall, built in 1924, is nadequate for presentday City-County opera-tions. Charlotte's popula-tion has increased , they say, seven-fold in the last 60 years. Officials explain

60 years. Officials explain the result is City Hall and the City Hall annex have become inefficient in hand-ling the City-County needs. The proposed City-Coun-ty Government center is a 313,000 square foot edifice that will be located down-town in the block fordered by Third and Fourth Streets, Alexander and Streets, Alexander and Davidson Streets. The pro-Davidson Streets. The pro-posed building will be 15 stories with an adjacent parking lot of 780 parking spaces for employee and public parking. The new center will cost an estimated \$32.7 million. Yet, City officials are quick to relate that no tax increase for Charlotte re-sidents will be necessary.

"The City of Charlotte has a triple 'A' credit rating a triple 'A' credit rating and a capacity of over \$90 million in bond issue passes," revealed Bobby Lowery, co-chairperson for the City-County Govern-ment Center Bond Committee, in a recent Char-lotte Post article.

Concerning this bond issue, the City Council is

hoping that Charlotte residents will agree that "owning is cheaper than rent-ing." Due to overflow, the City is now paying almost City is now paying aimos, \$1 million a year for rent-ing office space in the Cameron-Brown and Inde-pendence Buildings. If the City-County Government Center is not built, space rental for the next 30 years will cost the City \$56.6 will cost the City \$56.6

million. However, officials stress that in 30 years the City will own the \$32.7 million structure, saving the city \$24 million.

More benefits will accrue, states the City Council, because the new City-
