ogist of Oakland, California. He also noted that the NMA House of Delegates urged school based clinics, more funding and more slots for medical educa-tion and increased federal funding for research, treatment and education on AIDS, hypertension, heart disease and diabetes all of which disproportionately strike black America

Dr. Penn-Wiggins, of Washington, D.C., is professor and chair of the Department of Pathology, Howard University College of Medicine and Howard University Hospital. She will be installed as NMA's 88th president next summer in Orlando, Florida, the second woman to hold the posi-

A graduate of Wellesley College, she received her medical degree from the University of Virginia School of Medicine. She completed her post-graduate training in pathology at Massa-chusetts General Hospital, during which time she served as a Teaching Fellow at Harvard Medical School.

A faculty member and assistant dean at Tufts University for 12 years, she joined the Howard medical faculty in 1982. She is a member of Delta Sigma Theta Sorority, Inc. and of Links, Inc.

She is married to Dr. Henry W. Wiggins Jr., a Chicago radiologist and an NMA trustee.

Dr. Bransford is a native of Huntsville, Alabama, a graduate of Tennessee State University, Nashville, and Meharry Medical College in the same city. He received his training in general surgery at Kate Bitting Reynolds Hospital, Winston-Salem, N.C.


