PROGRESS OF LAND BANKS.

Farm Loan Board Recommends Increase in Lending Power and Authority to Write Insurance.

Increase in the lending power of the Federal land banks and the grant of authority for them to write fire insurance on farm property, are advocated by the farm loan board in its annual report submitted to Congress.

Modification of the Federal farm loan act so as to make the minimum loan \$500 instead of \$100, and maximum loans \$25,000 instead of \$10,000 also was urged.

The report was described as covering "the first year of operation" of the farm loan system, the first year of the board being spent in organization.
