

Enlist Negroes As Mess Attendants

The navy recruiter at Wilmington states that young negro men are now being enlisted with the rating of mess attendant third class. The requirements for enlistment are: Must be at least 18 and under 26 years of age, must be of good moral character with no police or juvenile court records, must be able to read, write and do simple problems in arithmetic, must be unmarried and with no dependents.

Only negro men are eligible for enlistment in the messmen branch of the navy, and the duties of mess attendants are in connection with the preparation and serving of food to and general attendants to officers.
