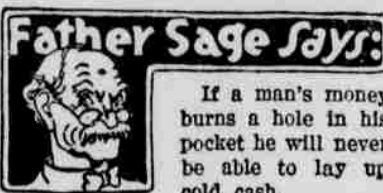

BOARD OF EDUCATION HOLDS REGULAR MEETING

The County Board of Education held its regular monthly meeting Monday at the office of Superintendent Workman with all members present.

A number of matters pertaining to school affairs were discussed among which was that of how to get High School pupils in the isolated districts to a High School. Some arrangement will have to be made to take care of these children. The board decided to take out compensation insurance for all teachers, truck drivers, mechanics and office force. This is required by the law. The board gave considerable time to a discussion of finances and on Wednesday Chairman Taylor and Superintendent Workman held a conference with the Board of Commissioners relative to discuss the need of the schools for funds.

TWELVE CENTS AVERAGE AT NEW BERN ON OPENING DAY

New Bern, Sept. 3.—The two local warehouses sold an estimated 120,000 pounds of tobacco today at an average, said by warehousemen to be 12 cents a pound, prices ranging from four to 30 cents. The opening break was not as heavy as last year. The prices ranged about the same. Considerable dissatisfaction was noticeable among the growers. Low grade tobacco, in the main, was offered today.

some funds. County Auditor Plint and Chairman Bushall said that they had made many efforts to borrow some money but without success and would thank anybody to tell them where it could be had.

At the afternoon session there was same discussion of county finances and then after auditing some bills and renewing some notes the board adjourned.

County Auditor's Report

The report made by the County Auditor, with the exception of the financial statement, reads as follows: Honorable Board County Commissioners, Carteret County, Gentlemen:—

Receipts during the month of August were very low. Our expenses have continued about as usual. We have lived within our income with the exception of Debt Service and of course over this we have no present control.

For some reason unknown to us the State Highway Commission did not honor our July or August requisition for Gasoline Tax Fund until August 25th, and this tended to confuse our Debt Service Fund. I also wrote the Highway Commission regarding the \$26,144.31 they owe us but they do not seem to know when we will receive it.

While on the subject, the public still has the impression that the State Highway Commission offered to not only take over the roads in Carteret County but also offered to pay for same. The truth is the Highway Commission has never offered to do anything. This Board of Commis-

sioners by due resolution did ask the Highway Commission to take over the roads from Beaufort to Atlantic and from Mansfield to Stella but they merely acknowledged receipt of resolution without action and this board then by suitable resolution requested that the Gasoline Tax be applied to our Debt Service. This was held up until we had written twice concerning it. Any one wishing to see this correspondence can see same in this office at any time and verify my statements.

Grain-Hay Mixtures Suitable For County

(By Hugh Overstreet County Farm Agent)

It is time to order your seed for hay and grazing this winter and next spring. Every farmer in Carteret county needs to plant several acres of these crops. Some good mixtures recommended by our state Agricultural Agronomist are: For hay: Oats 2 Bu., Barley, 1 Bu., Wheat 1 pk., Vetch 15 lbs., r Barley, 1 Bu. Oats 2 Bu., Vetch 20 lbs. Another good mixture for hay is: Wheat, 1 Bu., Barley 1 Bu. and Vetch 20 lbs. For grazing: Abruzzi rye, 1 bu., sow Sept. 15 to Oct. 1st.

Barley 1 bu. sow Sept. 15 to Oct. 1st.

For soil improvement: Vetch 25 lbs., Crimson clover 20 lbs., Austrian winter peas 30 lbs.; and Abruzzi rye 6 pks.

Fertilizer recommended for these fall grain crops is: 400 lbs. to the acre applied at the time of planting. This fertilizer should contain 8 per cent of acid phosphate, 4 per cent of nitrogen and 4 per cent potash.

I have been submitted with the following prices on fall seed grain from reliable seedmen: Fulghum oats, \$1.00 per bu. Abruzzi rye, \$1.75 per bu., Hairy vetch, 11c per lb., Beardless barley, \$1.75 per bu., Austrian winter peas, 11c per lb., Crimson clover, 16c per lb., and Winter wheat \$2.20 per bu. All of these seed have been tested by the N. C. Department of Agriculture for purity and germination.

I shall be glad to order seed for those who wish me to, but it will be necessary to get in touch with me either by letter or in person at the earliest possible moment, so that I may be able to pool all orders and get them placed before this good reliable supply of seed is exhausted.
