The "Bond Reserve Fund" has been increased during the year to the amount of \$2,055.72 and the setting aside of this amount com plies with all legal requirements: -This fund now aggregates \$13, 590.15 and is on deposit with the following parties, to wit: Alamance Loan and Trust Co.

Piedmont Trust Company, You will observe the 'Floating Debt' is \$20,550.39 as against \$27,5 220.11 on May 1st 1912, showing payments of \$6,669 72. The pr sent floating debt being covered by notes of the city and held by the following parties, to wit:--


