General Metts stated that nodification in this policy was made essary by an increasingly large mber of registrants who are ap rently undertaking to abuse the licy of leniency in an effort to ade military service. The modified policy, which was ssed on to all selective service agens in the state today, is as follows: When a registrant acquires marshould be assumed that both pars concluded the marriage knowing t the registrant was subject to rly call for service and were pre-

red to take the consequences, and erefore deferment in such cases uld not appear to be justified. But en a registrant has indicated on questionaire that he is engaged ing the date set for the wedding has given similar information in iting to the local board and the ding date falls after issuance of tice to appear for physical exami tion, his case should be considered the same way as those who mard after registration, as provided by endment 77 to selective service rulations.

"Of course, there may be other aditions which would obviously nper the above announced modifion of policy, e. g., proof that the fe was pregnant, or conclusive eviice of absolute dependence wherein wife would suffer undue hardship compelled to live on the regisnt's income as a soldier, etc.

This modified policy, General Metts inted out, is in line with a recent endment to the regulations, which as follows:


