PARK ARCHITECTURE.

The New Pavilion to be Erected in Latta Park.



The News gives a faithful illustration of the new Pavilion at Latta park shortly to be erected for special use of Charlotte's colored population. The cut was made by the News' special artist on the spot and represents the beauty and general outline of the structure as drawn by Mr. Charles Hook, the architect. While not so elaborate as its more pretentious neighbor which now adorns the entrance to the Park its utility and general convenience are marked features, and it will prove a most convenient resort for that race which can enter into enjoyments with a rest unsurpassed by the Caucasian. The location of the building will be on this side of the lake and 4x90 feet with a veranda skirt log it for four fifths of its dimensions. The ball room will be of a convenient size 30x75 feet, with the necessary dressing and retiring rooms. Looking over the placid waters of the lake, the gastronomic department, presided over by Major L. A. Bourke, whose experience well fit him for the catering supervision. Here and there in close proximity will be swings, swinging chairs and other means for the amusement of children. In a general way other improvements are in contemplation, and it may be put down as a certainty, that Latta park this summer will be the Coney Island of the South. Every move made by its owners last year was highly appreciated by the people of Charlotte. Every entertainment a grand success, so that every effort will be made to contribute additional attractions as the management can procure them. At the earliest opening of mild weather, handsome summer cars will be put on the electric line, increasing the carrying capacity besides affording the most pleasant means of transport.

SHOOTING WHILE HUNTING.

A Fatal Accident Near the City, Late Saturday Afternoon.

Mr. John Johnston, a citizen of Paw Creek township, this county, accidentally shot and killed himself almost instantly, late Saturday afternoon. Mr. Johnston with his brother and two young men were hunting squirrels in a piece of woods, a mile from Mr. Johnston's house they saw several squirrels in a tree. The squirrels apparently took refuge in a nest in the branches of the tree and the hunters decided to cut down the tree. While the tree fell, the squirrels could not be found. Mr. Johnston picked up his gun which had been laid on the ground by the side of the fallen tree, and as he did so he was looking up into another tree to see if the squirrels were there. As he was drawing his gun toward him the hammer struck on the tree and one barrel was discharged. The bullet entered Mr. Johnston's side. He staggered a step, fell into the arms of his companions, the blood streaming from his mouth and nostrils. He gave two or three gasps and expired.

Mr. Johnston was 29 years of age and leaves a wife and one child.

A Man in the House.

This morning about daylight she found that the match supply was exhausted, so she went into the house and reached up to the garret in the front hall to get a paper lighter. There was no evidence that he had invaded any of the bed rooms, and it is quite certain that he stole nothing.
