

Morrow-Bass Co. To Open Up March 15th.

Mr. J. H. Bass, who is to be in charge of the Morrow-Bass Co. which will be located in the Henderson Building, on East Trade Street, N. Y. arrived in the city from New York, where he has been buying goods for the new firm.

March 15th is the date set for the opening. The stock of goods will be complete in every respect and will fill the entire three floors of the building, the amount of floor space being about 2,000 square feet.

A chain of five stores is operated by the Morrow-Bass Co., of which the one here is the latest and the largest. The other stores are located at Anderson, Dickens and Bishopville, S. C., and Aberdeen, N. C.

The three floors of the building will be devoted each to a special line of goods. The first floor will be devoted to silks, dry goods, notions, clothing and shoes. The second floor will contain the millinery goods; the third floor, the wholesale department.

Mr. J. H. Bass will be in active management of the store. Mr. H. L. Bass, who for many years was with the Tappan-Loug Co., will be assistant manager. Mr. C. W. Andrews, of Albemarle, will be in charge of the dress goods department. Miss Emma Campbell will be in charge of dress goods and silks. Messrs. W. W. Moore and E. T. Parker will be in charge of the shoe department.

Where are teachers to be had for these schools? They should be turned out by the A. and M. College and that college should be the direction and guidance of these schools so as to make them effective. Dr. Maynard has given a strong argument for the Dowd bill in calling attention to the new and valuable Farm Life Schools. The money now expended on the state test farms, could be saved and the property could be converted into Farm Life school sites.

The Western Union "Day Letter." The Day Letter is the latest Western Union innovation to popularize and extend the facilities of the telegraph service. That company announces today the inauguration of the fifty-word Day Letter as the day companion to the fifty-word Night Letter, which is now so much used for all kinds of correspondence.

It is just a year since the Western Union launched the Night Letter and the popularity and success of that service in providing the means for an extended use of the telegraph by the public has prompted the company to give to the public similar advantages in the day service.

The Day Letter is to be written in plain English; code language or code words not accepted. Day Letters are to be transmitted at the facilities of the company will permit during business hours of the day, full rate telegrams having priority of transmission.

As the wires of the company are in much demand during the mid-day hours, it is advisable that Day Letters should be filed as early in the day as possible. This is desirable so that the company may despatch and deliver Day Letters within the business hours of the day on which they are filed.

Day Letters will be accepted at all offices of the Western Union at any hour during the day, or they may be sent in by telephone.

The rate charged for a Day Letter of fifty words or less is one and one-half times the fifty word Night Letter rate, and for each additional ten words or less one-fifth the initial charge. For example, the Night Letter rate between New York and Chicago is 50 cents, the Day Letter rate will be one and one-half times that of 75 cents, with 15 cents for each additional ten words. The New York-San Francisco Night Letter rate is \$1.00; the Day Letter rate \$1.50.

The Day Letter and the Night Letter give to the United States the cheapest telegraph service in the world.
