Federal Court Convenes Today

Judge James E. Boyd Presides -Grand Jury Selected And Charged - Fifty-nine Cases on Docket-Other Federal Officers in Attendance.

The October term of federal court convened this morning at 11 o'clock in the court room of the post office, with his Honor, Judge James E. Boyd, presiding.

#### The business of the court this morning was the selection o fthe grand jury, and Judge Boyd's charge to it. Fifty-nine cases, concerned for the most part with illicit distilling and re-tailing, are on the docket for trial at this term, and court will sit until they are disposed of.


