Washington, Feb. 20.—Frederick Douglass, the well-known colored orator, died suddenly at 7 o'clock tonight of heart disease at his home in Anacostia, a suburb of Washington. He was a prominent figure in the woman's convention this afternoon, when he occupied a seat upon the platform. He was apparently in the best of health at that time.
