A DOG FIGHT.

Cleveland and Hill Men Strive for the Mastery—A Drawn Battle.

ROCHESTER, N. Y., August 21—The Democratic caucuses in the city of Rochester and the country districts of Monroe county were held last evening under the arrangement made by the State committee looking to the pacification of the Hill and Cleveland factions of the party. The results as a whole were surprising and showed that the quarrel between the factions, which have been at daggers drawn for several years, had not been thoroughly harmonized. In ten of the twenty wards of the city each faction was successful, and in the country as a whole the same proportion marked the result, the Cleveland men carrying the first and third assembly districts and the Hill men the second and fourth. This will make an even break for State committeemen. Divided on the lines of senatorial districts, the Hill men carried the forty-third and the Cleveland men the forty-fourth.

BICYCLE ORDINANCE.

Be it ordained by the commissioners for the town of Concord, N. C.: Section 1. That the bicycle ordinances Nos. 73 and 77 respectively passed by the board on the 11th day of September, 1894 and on the 13th day of August, 1895 be and the same are hereby repealed.

Section 2. And be it ordained by the commissioners for the town of Concord: That any one who shall ride a bicycle on any sidewalk within the corporate limits of the town of Concord, N. C. shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined five dollars or imprisoned for ten days.

Section 3. Any one who shall ride a bicycle across any of the public crossings within the corporate limits of the town of Concord at a greater speed than an ordinary walk shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined five dollars or imprisoned for ten days.

This ordinance shall be in effect on and after August 23, 1895. By order of board of commissioners.
