BICYCLE ORDINANCE.

Be it ordained by the commissioners for the town of Concord, N. C.: Section 1 That the bicycle ordinances Nos. 73 and 77 respectively passed by the board on the 11th day of September, 1894 and on the 13th day of August, 1895 be and the same are hereby repealed.

Section 2. And be it ordained by the commissioners for the town of Concord: That any one who shall ride a bicycle on any sidewalk within the corporate limits of the town of Concord, N. C. shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined five dollars or imprisoned for ten days.

Section 3. Any one who shall ride a bicycle across any of the public crossings within the corporate limits of the town of Concord at a greater speed than an ordinary walk shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined five dollars or imprisoned for ten days.

This ordinance shall be in effect on and after August 23, 1895. By order of board.

CATTLE STEALING.

Large Band of Negroes in Texas Organized for Plunder.

WACO, Texas, September 17.—Capt. Joe W Taylor, county attorney of McLennan county, has laid before the grand jury the constitution, by-laws, list of officers and secretary and treasurer's report of an association of negroes organized for the purpose of stealing cattle and horses.

While the rolls do not show any names of white men, there are evidences in possession of the county attorney that the cattle stealing syndicate was to some extent under control of whites.

The thieves had monthly meetings, at a rendezvous and have at least once declared dividends. This is shown by the report of the treasurer. Their operations have been extensive and the losses, though scattered over a wide territory, are large. It is probable that in some cases they shipped stolen cattle in car load lots. Arrests will follow.
