### DECIDED AGAINST BISHOP HAID.

The Heirs of Lawrence Brown, Who Willed His Property to the Catholic Church, Win—An Appeal Taken.

WILMINGTON, N. C., Oct. 5.—A case of some interest was tried in the Supreme court here this week in which the Rev. Leo Haid, Catholic bishop of North Carolina, was defendant. Some years ago Lawrence Brown, a merchant of this city, just before his death, conveyed all his property, estimated at \$19,000, to the Catholic Church. Brown's heirs, who live in the State of Ohio, brought suit to recover and the jury today returned a verdict in their favor. An appeal was taken by defendant to the Supreme Court of North Carolina.

Amos J. Cummings Nominated.

NEW YORK, Oct. 5.—Amos J. Cummings was nominated for Congress by Tammany Hall, in the Tenth Judicial District to-night, to fill the vacancy caused by the death of Andrew J. Campbell. The State Democracy of the same district nominated Wm. J. Brown, who is a printer and a leader in labor circles.

#### The Steamer is Discharged.

WASHINGTON, Oct. 5.—Attorney General Harmon has instructed the United States Marshal at Wilmington, N. C., to discharge the steamer Commodore which has been detained at that point for suspected violations of neutrality laws. He has, however, directed that the arms taken from the Commodore be held for the present.
