

MUST DISPLAY SIGNALS.

New Regulations Relative to Rural Free Delivery Mail Service.

The following instructions have been issued by the fourth assistant postmaster general:

1. On and after July 1, 1906, patrons of the rural delivery service will be required to display signals on boxes when they leave mail in them for carriers to fast coming together for self pro- when serving their routes, will not collect, as, after that date, carriers, tection and for the benefit of the be required to open and examine any mail boxes except those in which they have mail to deliver and those on which signals are displayed to indicate there is mail for carriers to collect.

2. Those patrons whose boxes are not provided with signals must attach thereto some device which, when displayed, will plainly show passing carriers there is mail to be collected.
