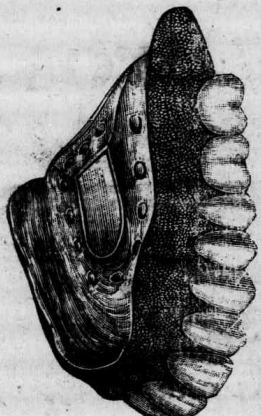

The third great element of the national preparedness programme was brought into the House of Congress Thursday.
