

While Halifax, Bertie and Hertford Counties Get About \$650,000 Net Profit a Year From Legal Sales . . . Northampton Gets Nothing . . . And Loses A Lot of Its Shoppers



With Legal Control Surrounding The County, Tight Economic Squeeze Placed On Northampton

This Means:

- 1. Because Northampton doesn't have Legal Control, its tolks purchase ABC-beer-wine in nearby Legai Sale towns and also buy groceries, hardware, clothing and other items there.
- This not only hurts Northampton merchants, it hurts every Northampton citizen, because lost business means fewer jobs at home.
- 3. Northampton's population has declined 1,600 people in the last 10 years because so many young people had to leave the county to find jobs.
- 4. The lost revenue makes it very hard for Northampton to get new industry to provide more jobs, because we lack the funds to provide the things new industry expects (such as water and sewer lines, recreation areas, etc.)
- 5. As long as these conditions exist, Northampton will suffer while its neighbors grow and prosper.
