Gaston Budget Is \$21,932; Rate \$1.35

GASTON - A 1965-66 fiscal budget calling for expenditures of \$21,932.26 will be voted on by Town Board members here this month.

Adopted last month, the budget is based on a town valuation of \$1,113,501. The tax rate remains the same, \$1.25 for the general fund and 10 cents for the building fund, a total of \$1.35 per \$100 valuation.
