


"Our world has passed away, In wantoness o'erthrown. There is nothing left today But steel and fire and stone!

NEW DEMAND FOR MILK SUPPLIES

Army camps and increased

Carolina have accounted for a new demand of approximately 10,000 gallons of fluid milk daily, according to W. L. Clevenger, dairy manufacturing specialist of N. C. State College.

The requirement is still on the increase, since new camps are State. In addition, the normal demand is increasing as more money is placed in circulation.

This situation, Clevenger said, means that North Carolina is now doing its biggest dairy business and will be expected to do an even bigger job before the war is over.

Indications are, he continued, that the State will be able to meet this new demand without a great deal of trouble, since it standpoints.
