RALEIGH, May 14.—Governor O. Max Gardner yesterday offered a reward of \$400, the maximum he is authorized to offer under any circumstances, for the apprehension and conviction of those responsible for the destruction of the headquarters of cotton mill strikers at Gastonia on April 18 and at the same time made public the fact that his own unsuccessful efforts to secure the apprehension of the guilty parties included the employment of a detective, who remained on the scene for 16 days.
