Sealed bids will be received until 11 o'clock A. M., North Carolina Time, September 29, 1981, by the undersigned at its office in the City of Raleigh, North Carolina, at which time and place such bids will be

opened for \$680,000 Sanitary Sewer Bonds of the County of Warren, North Carolina, dated June 1, 1981 (unless awarded to the United States of America in which case the bonds shall be dated as of the date of delivery thereof), and maturing annually, June 1, \$8,000 1984 to 1986, inclusive, \$9,000 1987 and 1988, \$10,000 1989 and 1990, \$11,000 1991 and 1992, \$12,000 1993 and 1994, \$13,000 1995, \$14,000 1996 and 1997, \$15,000 1998, \$16,000 1999, \$17,000 2000 and 2001, \$18,000 2002, \$19,000 2003, \$20,000 2004, \$21,000 2005, \$22,000 2006, \$23,000 2007, \$24,000 2008, \$26,000 2009, \$27,000 2010, \$28,000 2011, \$30,000 2012, \$31,000 2013, \$32,000 2014 to 2018, inclusive, and \$17,000 2019, without option of prior payment (unless awarded to the United States of America, Farmers Home Administration).

Denomination \$1,000, bonds numbered 1 to 680, inclusive; principal and interest (semiannually on June 1 and December 1, except interest on any bonds registered as to both principal and interest shall be payable on June 1, 1982, and annually thereafter on June 1) payable in legal tender at First-Citizens Bank and Trust Company, in Raleigh, North Carolina; payment of interest on any bonds registered as to both principal and interest by check mailed to the registered owner; general

obligations; unlimited tax; coupon bonds registrable as to principal alone or as to both principal and interest; delivery on or about October 12, 1981, at place of purchaser's choice. There will be no auction.

At the option of the purchaser of the bonds, a fully registered bond without coupons in the amount of \$680,000 will be issued, exchangeable within 90 days after notice for coupon bonds in the denomination of \$1,000.

Bidders are requested to name the interest rate or rates, in multiples of 1/4 or 1/10 of 1%, not exceeding an average annual net interest cost to the County of 5% and each bidder must specify in his bid the amount and the maturities of the bonds of each rate. The difference between the lowest and the highest rates named in the bid shall not exceed 2%. No bid may name more than six interest rates, any of which may be repeated. All bonds maturing on the same date shall bear the same rate of interest and no bond shall bear interest at more than one rate. No bid of less than par and accrued interest will be entertained. The United States of America, acting through the Farmers Home Administration, has entered into a Loan Agreement with the County of Warren pursuant to which the United States has agreed to purchase the bonds at their par value and at a rate of interest of 5% per annum, provided that no bid is received specifying an interest rate or rates not exceeding an average annual net interest cost to the County

of 5%. As among such bids, the bonds will be awarded on the basis of the lowest interest cost to the County, such cost to be determined by deducting the total amount of any premium bid from the aggregate amount of interest upon all of the bonds from their date until their respective maturities. If no such bid is received, the bonds will be sold to the Farmers Home Administration pursuant to said Loan Agreement.

Each bid must be submitted on a form to be furnished with additional information by the undersigned, enclosed in a sealed envelope marked "Bid for Bonds," and must be accompanied by an official bank check, a cashier's check or a certified check upon an incorporated bank or trust company for \$13,600, payable unconditionally to the order of the State Treasurer of North Carolina, on which no interest will be allowed. Award or rejection of bids will be made on the date above stated for receipt of bids and the checks of unsuccessful bidders will be returned immediately. The check of the successful bidder will be held, uncashed as security for the performance of his bid, but in the event such bidder shall fail to comply with the terms of his bid, the check may then be cashed and the proceeds thereof retained as and for full liquidated damages.

The unqualified approving opinion of LeBoeuf, Lamb, Leiby & MacRae, New York City, will be furnished without cost to the purchaser. There will also be furnished the usual closing papers. The right to reject all bids is reserved.
