North Carolina Congressmen C. B. Deane and Graham Barden seem determined to try to keep the Air Force from setting up a big air base at Raleigh-Durham airport. They cite the millions already invested at two other places and claim money would be wasted if it were spent at Raleigh-Durham.

1. Millions already have not been spent at Raleigh-Durham, too.

2. If Raleigh-Durham is not selected, the air base will not be placed in North Carolina, according to information from Washington.
