preme Court of the Student Body composed of a chief justice and four associate justices appointed by the President of the Student Body and confirmed by a two-thirds vote of the Student Legislature.

The Legislature would have the power to impeach the justices for misconduct or nonperformance in office.

The proposed Supreme Court would replace the existing Constitutional Council which student leaders have found to be unsatisfactory.

The new court would have original jurisdiction in controversies concerning executive and legislative action raising questions of law arising under the Student Constitution or laws enacted under its authority.

The Supreme Court would also hear appeals from the lower courts when precedicial error is alleged to have occurred.

Other changes included in the amendment are the establishment of a Panhellenic Court and the clarification of the jurisdiction of the various lower courts.

As required by law, The Daily Tar Heel is publishing the provisions of the amendment along with the provisions of the existing Constitution which the amendment affects. The provisions of the proposed amendment are printed in bold face type.

The Student Legislature shall have powers:

h. To impeach and bring to trial by a majority vote, any student official holding a position made elective by law, or a justice of the Supreme Court of the Student Body, and remove from office by a twothirds vote;


