Flowers

SWEET PEAS-Spencer Mixed. Garden

GARDEN PEAS-Smooth varieties: First & Best, Alaska, Early

SPINACH - Bloomsdale, for spring and early summer.

CABBAGE — Set frost-proof plants, Early Jersey Wakefield, Wakefield, Charleston Wakefield.

ONIONS:—"potato onion" sets. LETTUCE—Seed in cold frame or garden: Grand Rapids (curled). In cold frame only, N. Y. Wonder-

ful, Icoburg.
POTATOES—Irish Cobbler,
Spaulding Rose.

Field Seeding

LESPEDEZA-Korean, Common, Kobe, Tennessee 76.

CLOVERS-Red, Sapling, Alsike, White Dutch.

GRASSES Kentucky Blue, Red Top, Orchard, Rye Grass.

Other Crops-OATS: Fulghum;

Spade or plow in all manure available on rest of garden. Lime garden if possible, but leave lime and manure off potato land.

Finish all fruit tree pruning and dormant scale spraying (spray oil, lime sulfur with arsenate of lead or nicotine sulphate, according to maker's directions).

#### Federation Offers Free Planting Information

With gardens and field crops being planted all over the county, Lawrence Ramsey, manager of the local Farmers Federation ware-house has called attention to the spring planting issue of the Farmers Federation News which is being given to people who will call at the local cooperative warehouse. Extra copies have also been sent to all county agents and agriculture

A garden and field seed planting chart is a feature of the issue, showing at a glance the seed needed per hundred feet of drill or per acre, the depth and spacing, the proper fertilizer, and other facts. An insect spray chart, lists of garden and field seed varieties recommended for Western North Carolina, and other planting information is carried.

Another article of interest is on mountain shrubs, such as rhodo-

dendron and azalea, which can be used to beautify the home grounds. The issue also contains information on the Farmers' Federation's new patronage dividend plan for farm-

## Patronage Plan

Put into Effect by Local Farm Federation

Operation of the new patronage dividend plan began Monday at the local Farmers Federation warehouse, with farmer's receiving yellow coupons in dollar and five-dollar denominations covering their cash purchases and their sales of farm products.

According to the plan voted by the Farmers Federation stockholders meeting on February 22, the board of directors are empowered to declare a patronage dividend at the end of the year if in their opinion the condition of the business will permit, and if the dividend paid is to be in credit toward the ownership of a share of Farmers Federation stock, based on a farmer's coupons on his trade.

The patronage dividend plan is an important part of the cooperative principle, President James G. K. McClure has pointed out, because it is designed to return to farmer the benefits of his

trading during the year. The coupons are to be held by their owners and turned in promptly after the end of 1936.

## Final Foreclosure to Begin Soon After April 1st

Section 1 of an act of the 1935 General Assembly of North Carolina "TO ALLOW THE COUNTY OF MACON AND MUNICIPALI-TIES THEREIN TO REFUND TAX SALES CERTIFICATES," provides:

"That the County of Macon and the municipalities therein owning taxes, or tax sales certificates for land in their several units for the years 1927, 1928, 1929, 1930, 1931 and 1932, are hereby authorized, empowered and directed to enter into agreements with the owners of the lands covered by said tax sales certificates whereby said taxes, or tax sales certificates, ex-

clusive of interest and penalties, may be paid in installments covering a period not to exceed six years and bearing interest at the rate of six per cent per annum, payable annually from and after the first day of April, 1935; Provided, that unless the said County of Macon, municipalities therein and the owners of lands covered by said taxes, or tax sales certificates, enter into said agreements on or before the first day of April, 1936, this section shall become inoperative and the said County of Macon and municipalities therein are authorized to proceed with foreclosure proceedings as hereinafter set out x x x"

If you desire to take advantage of this deferred payment plan on deliquent taxes for the years mentioned, please take immediate action. Notes for this purpose can be obtained from the Board of County Commissioners or from C. Tom Bryson, Clerk to the Board.

By taking advantage of this plan, delinquent taxpayers of Macon County can save their property from foreclosure and greatly reduce interest payments. Tax sales certificates bear interest from date of sale at the rate of 8 per cent 'per annum; whereas tax lien notes provided for in the above act bear only 6 per cent interest per annum from April 1, 1935.

Persons whose property has been foreclosed for delinquent 1925, 1926 and 1927 taxes, and deeds made for same, can redeem their property by giving deeds of trust and notes for same.

The County is desirous of assisting all delinquent taxpayers to save their land. Anyone desiring further information concerning the Tax Refunding Act is advised to see C. Tom Bryson, Clerk to the Board of Commissioners.
