Robin Hood Farms to Give Vocational Training Without Charge

RALEIGH, May 25.-Mrs. Edwin Clarke Gregory, of Salisbury, was named chairman of the woman's committee to assist in raising funds for Robin Hood Farms, by the state executive committee.

The Robin Hood Farm movement is a non-commercial, non-sectarian vocational training project through which deserving Tar Heel boys and girls above high school age and without financial means for further education, can obtain without charge, practical experience and training in farming operations.

Mrs. Gregory is president of the Salisbury Woman's club and chairman of the Colonial Dames society of Rowan county. She is also North Carolina director for the Robert E. Lee Memorial foundation. She has held important offices with the Daughters of the American Revolution, including state regent, vicepresident of the National Society and vice-chairman of the National Defense committee for the South.

President Wilson decorated Mrs. Gregory with the World War service medal for Red Cross service. President Coolidge conferred upon her the Cross of Honor medal. President Coolidge, Chief Justice Taft and Chief Justice Hughes sent her on the American Flag goodwill tour of the world.

Mrs. Gregory has served as trustee for the University of North Carolina. Daughter of the late U. S. Senator Lee S. Overman, she is a granddaughter of the late State Chief Justice Augustus Summerfield Merrimon. Her son, Lee Overman Gregory, was recently appointed State Assistant Attorney General. Her husband, Edwin Clarke Gregory, served in the State Senate in 1937, and was nominated without opposition for the 1939 Senate.

"I know of no other person in the state so well qualified to act as chairman of the women's committee for Robin Hood Farms. Mrs. Gregory realizes deeply the need for helping deserving Tar Heel boys and girls to become self-supporting, respectable North Carolina citizens," said Secretary of State Thad Eure, in commenting on the ap-

pointment. Among prominent officials who have assisted in developing this unique plan are: George Ross Pou, state auditor; T. E. Browne, director vocational training; W. Kerr Scott, commissioner of agriculture; I. O. Schaub, extension director; George R. Ross, former director of state farms; J. Henry Highsmith, supervisor of high schools; and John W. Harrelson, dean of state college. John A. Park, publisher of The Raleigh Times, is chairman of the publicity committee.

Cows On Pasture May Need Grain Feed Too

When cows are turned on good pasture in the spring and early summer, the amount of grain fed in their ration can be reduced, said John A. Arey, extension dairy specialist at State college,

Grazing on lush grasses, a cow can obtain enough nutrients with the roughage to sustain her body and weight and produce a certain quality of milk.

A Holstein cow can eat enough grass to maintain body weight and produce about 30 pounds of milk a day-a Jersey cow 20 pounds. But when producing more milk, the cows should receive enough grain to compensate for the extra milk

A Holstein on good pasture needs about two-fifths of a pound of grain for each pound of milk she produces daily above 30 pounds.

A Jersey on good pasture, because her milk is richer in butter fat, will need about three-fifths of a pound of grain for each pound of milk she produces above 20 pounds

But Arey warned that the cows will need more grain when pasture is short as a result of dry weather early in the season, or when the pasture grasses become more mature in July and Rugust.

As the grass gets older, the amount of crude fiber is increased while the amount of nutrients decreases. On the other hand, grass that is just getting started early in the year is watery and low in feed value. The best grazing is secured between these two periods.
