Q. I am in college under the Korean GI Bill, and I have just about come to the end of my GI entitlement. If I run out of entitlement before the end of my semester, will I be allowed to continue my GI training?

A. If your GI entitlement runs out after you've passed the halfway mark of your semester, you will be permitted to continue under the Korean GI Bill to the end of the semester. Otherwise your GI training will end when your entitlement expires.

Q. I am a Korean veteran, and I've been thinking of using my GI loan rights to buy a house. Is there any hurry to buy a house, or do I have plenty of time?

A. You have plenty of time. Korea veterans have until January 31, 1965, to take advantage of their GI loan benefit. World War II veterans have only until pensions July 25, 1958.
