

**Seawell Is Subject of Magazine Article**

**Story of Carthage Judge Told in R. C. Lawrence Biography in State Magazine**

One of Moore County's prominent attorneys, Judge Herbert F. Seawell of Carthage, is subject of an article by R. C. Lawrence, North Carolina writer of many brief biographical sketches of prominent State citizens, appearing in the July 12 issue of The State magazine.

After describing some of the highlights of the Judge's colorful career in the State, the author quotes from Bion H. Butler's "Old Bethesda" to say, "Seawell is a man big enough to take the little end of the stick and still win."

Lawrence continues, in his own words, "He is one of the quickest, keenest, clearest thinkers our state affords, and I do not know his superior as a debater. His mental reactions are almost instantaneous and if perchance you finally get him in the air, he always lands on his feet—like a cat. He is a tremendous fighter, but he always fights in the open, always fairly, and he never makes an unnecessary fight . . ."

"Do you know where Judge Seawell got his passion for the underdog, the underprivileged, the forgotten man?" the article asks. "He got it right from the soil! For the Judge is a dirt farmer and is at his very best with a hoe, a shovel and other implements of agricultural warfare in his hands, a hat of straw crowning his head, and leading an aged and veteran mule by the reins—and thus equipped he assails the soil of Moore . . ."

**Diphtheria Vaccinations Continue Though No Deaths in County in Three Years**

The outstanding feature of the Summer immunization clinics now being held throughout the county is the number of small children being brought to the clinics by their parents for vaccination against diphtheria.

It is true that there were no deaths from diphtheria in Moore county in 1939 and 1940, and there have been no deaths so far in 1941, Moore therefore becoming one of the few counties in the state and also the nation to have no deaths in over two years from this disease. "We are now looking forward to the time when we will be able to say about diphtheria as we have of typhoid fever and smallpox that there have been no deaths in the county for eight or ten years," says Dr. J. Symington, Public Health Officer.

"We are glad, therefore, to see mothers voluntarily having their children vaccinated against this dreaded disease in encouraging numbers, and results will undoubtedly show the wisdom of the interest they are taking in the future protection of their children."
